Declaration of consent

I agree that my personal data (surname, first name, date of birth, e-mail address(es), club affiliation(s), address(es), telephone number(s) as well as entries made by myself in the online portal "TeamSL") will be collected, processed and used by the German Basketball Federation (DBB). The collection, processing and use of the data exclusively serve purposes resulting from the activity as a referee and which are basically connected with game operations of the German Basketball Federation including its regional federations and their sub-divisions.

I acknowledge that the online portal "TeamSL" (<https://www.basketball-bund.net>) operated by DBB is used for the organization and publication of games and tournament events as well as the data exchange required in this context. I agree that my surname and my first name will be published online for everybody in the context of assignment of games. Club administrators, league administrators and all other referees registered in the online portal have the possibility to retrieve my name and address data. Referee scheduler and federation administrators can also view my date of birth.

As a matter of principle, my personal data may not be shared with third parties; an exception applies to commissioned data processing in particular, but not exclusively, in the sports administration program Veasy as well as in the context of the DBB-BildungsCampus (elarning@basketball-bund.de), as far as this is required by the referee activity (e.g. maintenance of a referee register).

Upon ending the referee activity and upon my request, DBB will delete my personal data. If the deleting request conflicts with legal or associational obligations, the personal data will be blocked.

Upon written request of the user, DBB will provide information about the saved data within the scope of its legal obligations. This consent can be revoked in writing at any time with effect for the future. In case of revocation, all personal data will be deleted or blocked immediately. In order to obtain information or to revoke consent to the saving, using and processing of personal data, the referee may contact the Headquarter of DBB (Deutscher Basketball Bund e. V., Jochen Böhmcker, datenschutz@basketball-bund.de, Postfach 708, 58007 Hagen).

Data can only be deleted if they do not have to be kept for the fulfillment of obligations, for the maintenance of proper game operations, for example regarding existing sports law regulations or federation regulations, or for other legally prescribed reasons. If the referee is still active as a player and/or coach or is kept in TeamSL for other reasons (in particular, but not exclusively, e.g. as a team manager), the deletion shall not affect the data that the federation keeps for proper player or coach-administration.
